

WARRANTY REGISTRATION UTILITY TRAILERS

LIMITED WARRANTY

Dura Haul warrants its new products sold to the original owner sold in the United States, Canada, and Mexico as follows:

LED lights and electrical: Three (3) year pro-rated 100% in year one (1), 66% in year two (2), and 33% in year three (3).

Axles: One (1) year pro-rated warranty on axles, covering any defects in materials or workmanship. In the first year, the warranty covers 100% of parts and labor. In the second year, it covers 50% of parts only. Please note that axles are warranted by the original equipment manufacturer (OEM), not Dura-Haul.

Workmanship and Material: One (1) year pro-rated warranty free from defects in material and workmanship under normal legal use and service from the date of purchase as described by the specifications sheet and usage and rating sheet.

In addition, Dura-Haul's sole obligation, at its option will be to repair or replace any products, which upon inspection by Dura-Haul may be determined to be defective in material and/or workmanship. The warranty starts upon the purchase (delivery) of the trailer and ends at the expiration of the warranty period.

Warranty shall not apply to normal wear and tear, maintenance, poor or lack of service, adjustments, theft, misuse, fire, vandalism, objects striking the vehicle, or operated in excess of rated capacities or accident. Also not covered is any equipment which has been modified, altered or has unauthorized repairs in any way, or any items determined to be misused or not properly maintained, trailers that are second hand or used. It is the owner's responsibility to maintain and use the product as intended by Dura-Haul's product specifications. Warranties shall not apply to components on wear items such as cylinder seals, tires, suspension, bearings, brakes, hoses, valves, tarps or piping seals such as but not limited to gaskets, seats, seals, o-rings or diaphragms.

Any warranty claim request must be submitted in writing to Dura-Haul detailing the claim. Only work that is approved by Dura-Haul will be provided in writing by Dura-Haul before any work can be done or any parts can be returned to Dura-Haul. Dura-Haul reserves the right to have the work done at a Dura-Haul approved dealer location. Dura-Haul makes no warranties, either expressed or implied, except as provided herein, including without limitation thereof. Warranties as to the marketability or suitability for particular purpose or use. In no event shall Dura-Haul be liable for any direct, incidental or consequential damages of any nature, physical injuries, or losses or expenses or income resulting from any defective product or the use of any such product, including any damage or the loss of time, inconvenience, or loss of use of any such product. This warranty in no way obligates Dura-Haul to bear any costs of field testing, transportation, or third party repairs, unless authorized by Dura-Haul. Dura-Haul reserves the right to change our specifications, warranty and designs at any time.

Transportation charges are responsibility of customer and are required to be prepaid before any work or repair or part can be exchanged. In no event will Dura-Haul be liable for injury, business interruptions, loss of profits, indirect or incidental losses, personal injury, consequential losses or cost of delay.
